MODALITIES/RULES FOR END OF TERM EXAMINATIONS

SUBMISSION OF SCHOOLS/ROLL FOR END OF TERM

1. All schools must submit their interest in the exams at least two months to the examination
2. The submission must include classes and the number of roll of each class

PAYMENT OF EXAMINATION FEES
